Signal Word: Danger

Chronic:	Inorganic bromides may produce depression, emaciation and in severe cases, psychosis and mental deterioration. Bromoderma, a bromide rash, often occurs when bromide inhalation or administration is prolonged. This rash is usually found on the face and resembles acne and furunculosis. Gold compounds may cause irritation to the eyes and respiratory tract. Aplastic anemia may result from damage to the blood forming organs. Gold has caused tumors and reproductive effects in laboratory animals via implant, intraperitoneal and subcutaneous routes.
