Ingestion may cause burning in the mouth, esophagus and stomach. Inhalation of ducts and fumes may cause irritation of the respiratory tract and labored breathing and coughing. Sensitization, nausea, flushing of the face and ringing of the ears is also possible. Chronic ingestion may result in pericardia effusion, polycythemia, cardiac failure, vomiting, convulsions, and thyroid enlargement.
